

Terms and Conditions for AI for Industry Programme

1. Personal data

By agreeing to these terms and conditions, you consent to AI Singapore collecting your personal data for the purposes of managing and administering the Programme, examination and certification and disclosing your personal data to NUS partners and service providers, certification awarding bodies, examination agencies and funding agencies on a need to know basis.

2. Payment

2.1. Your registration will only be confirmed upon receipt of full payment of the course fees by AI Singapore.

2.2. Payment of course fees can be made via PayPal only and is non-refundable, except as provided under Section 5 of these Terms and Conditions.

2.3. If your company is sponsoring your course fee, your company has to accept the invoice issued by AI Singapore 7 workings prior to course commencement, in order to secure your place in the course.

3. Course Confirmation

3.1. The course confirmation is subject to your declaration that:

- a. You have made the correct payment of the full course fees based on whether you are a Singapore citizen / Singapore permanent resident or Others.
- b. You have agreed to provide, upon request by AI Singapore, your personal identification card for verification purposes, at any time.

3.2. AI Singapore reserves the right to immediately withdraw your registration and revoke your access to AI Makerspace, related course materials as well as your course certificate (if it has already been issued), if any of your declarations under 3.1 is found to be false and you will not be eligible for any course fee refund from AI Singapore.

4. Changes and Modifications

AI Singapore course schedules including course content, course fees and course availability are subject to change from time to time.

5. Cancellations & Refund

All cancellation requests must be received in writing. If notice of cancellation is given:

- a. Fourteen (14) working days or more before commencement of class, AI Singapore shall refund 100% of all course and assessment/examination fees (if any) paid by you.
- b. Less than fourteen (14) workings but more than seven (7) working days before commencement of class, AI Singapore shall refund 50% of all course and assessment/examination fees (if any) paid by you.
- c. Seven (7) working days or lesser before commencement of class, AI Singapore shall not refund any course fees paid by you.

6. Completion of Course and Issuance of Certificate

The “Foundation in AI” certificate will be issued to participants who have successfully completed all AI for Industry (AI4I) quizzes on AI Makerspace within the programme period.
